The U.S. Department of Energy (DOE) - together with NASEO and others, announced the launch of the SEED Collaborative, which assists states with building performance data sets.

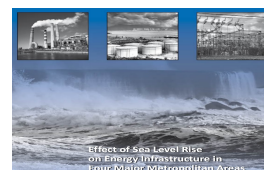

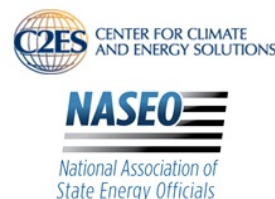
The Tennessee Department of Environment and Conservation (TDEC) recently completed a pilot project to test computer power management (CPM) technologies.
